 - (2) Japanese suggested name: Applicants may suggest a name, or it could be left blank.
 - Submit the Application Form with a copy of the application form (INCI Name Application) submitted to the International Nomenclature Committee of PCPC and the letter of determination of the INCI name from PCPC.
 - C. The case of a new ingredient which does not have an INCI name. Prior to applying to JCIA, application to the International Nomenclature Committee of PCPC for an INCI name has already been submitted.
